Abstract

Umarae Quantum X (UQX) is a utility token designed to power a user-centric Web3 ecosystem combining daily investment returns, gamified mining, airdrops, offerwall rewards and future e-commerce & NFT utilities. The aim: create a sustainable token economy where users both earn and contribute to growth.

Total Supply: **100,000,000 UQX**

Problem Statement

If you look at the crypto industry, many tokens are running only on speculation — without utility, their long-term value doesn't survive. Users want consistent, transparent earning opportunities with a trusted token. UQX aims to fill this gap.

Our Solution

UQX brings a hybrid approach: liquidity and trust through presale; daily engagement via mining and task-based reward systems; real USD revenue from offerwalls and surveys; and sustained token demand

Quick Summary

UQX = utility token for an integrated Web3 ecosystem. Mining + Presale + Tasks + Offerwall = multi-revenue & multi-use platform.

Core Components

Daily Earnings Dashboard

Investment based daily returns (transparent, tracked on user dashboard).

Mining Pool

Gamified mining via web tasks & activity — real feel of mining without building a new blockchain.

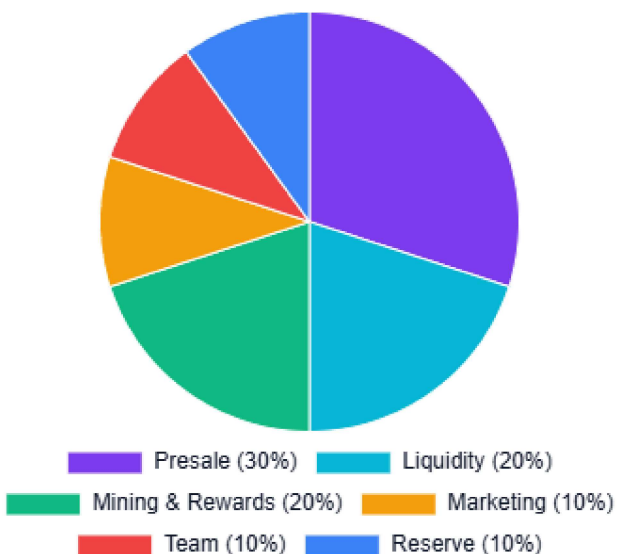
Offerwall & Tasks

Surveys, videos, app installs — third-party partners pay USD and users earn UQX.

Presale & DEX Listing

Structured presale rounds, liquidity lock & PancakeSwap listing for price discovery.

Tokenomics

Team tokens: **12 months lock** + phased unlocking.

Liquidity: **Lock 6–12 months** (proof to be displayed on site).

Mining & Reward Design (Technical Summary)

Mining pool: **20,000,000 UQX** allocated. Mining architecture is off-chain reward distribution: user actions tracked on server → server issues blockchain transfers or mints internal credit which user can claim on-chain.

Recommended Mechanics

- **Daily pool:** dynamic base (example start 10,000 UQX/day).
- **Hybrid cap:** per-user cap (e.g., max 5 UQX/day base) + share-of-pool based on activity.
- **Anti-dump:** vesting on large airdrops and tiered claiming (50% now, 50% after 30 days) + cooldown for small wallets.
- **Distribution:** Admin issues batch transfers via secure backend or users claim via smart contract (claim contract recommended).

Detailed distributor contract & backend scripts will be open-sourced for audit before Presale.

Roadmap (Concise Timeline)

Phase 1 — Foundation

Contract deployed & verified, website live, community channels open.

Phase 2 — Community & Airdrop

Airdrop campaigns, early user growth (10k+ wallets), announce mining mechanics.

Phase 3 — Presale & Liquidity

Presale rounds (staged), liquidity lock, PancakeSwap listing.

Phase 4 — Mining Live & Utility

Offerwall + tasks live, mining distribution active,
CoinMarketCap/CoinGecko applications.

Phase 5 — Exchange Expansion

First CEX listings + staking & NFT integration +
mobile app release.

Anti-Fraud & Audits

Before major listings we will: (1) run third-party security audit, (2) publish audit results, (3) open-source distribution scripts for community review.

Presale Plan (High-level)

Staged presale with price increases between rounds.
Example: Round1 \$0.005 → Round2 \$0.0075 → Round3 \$0.01. Softcap & hardcap to be decided on launch page.
Presale buyers get claim instructions & liquidity transparency.

All presale smart contracts & multisig owner wallets will be published and proof of locked liquidity shown on the website.
